Summary of Recent TRPs: Institutional Groupings (#48)

- Background:
 - Hard to classify some institutions (e.g. highest degree awarded)
 - Institutional mergers
- Areas of Review:
 - Cost of Attendance
 - Admissions
 - Retention Rates
- Recommendations for Data Collection:
 - Separately for Each Degree
 - Based on Screening Question
 - No Change but Add Clarification

Summary of Recent TRPs: Institutional Groupings (#48)

- Recommendation for Institutional Groupings:
 - Group Institutions by Level Combined with Primary Degree
 - New sectors:
 - Primarily bachelor's degree; with associate's; Primarily associate's degree; with bachelor's, etc.
 - New sub-sectors:
 - Sector 1a: Public 4-year, primarily bachelor's degree; Sector 1b: Public 4-year, primarily associate's degree, etc.

Summary of Recent TRPs: The Public Face of IPEDS (#49)

- Discussion of IPEDS Web Tools & Publications
 - Offer a better way to present the data dictionary as a web-searchable platform.
 - Provide documentation for the front end on what users get on the back end (for all data tools).
 - Consider adding a new derived variable to identify states in regional compacts (e.g. SREB).

Summary of Recent TRPs: Gender (#51)

- Sex or Gender?
- What are institutions collecting?
- Potential changes to data collection:
 - Include gender unknown in the aggregate totals but not in the detail (report gender data using the current two categories)
 - Add category for reporting gender unknown
 - Add category to accommodate gender identity in categories other than male or female in a separate category from gender unknown
- There are no proposed changes to current IPEDS reporting requirements as a result of this TRP. The work from this informational-gathering TRP will be used as a resource when such future guidance may be issued.
